POSITION DESCRIPTION

Position Title: Board and Ski Officer

Reporting To: Surf Life Saving Operations and Surf Sports and Competition Committees

This is a voluntary position and carries no salary or designated hours

Purpose of the Position

The Board and Ski Officer provides leadership in all Board and Ski operations of the club including providing assistance to the Club Captain and Surf Sports Officer in relation to their roles.

Pre-requisites

To nominate for the position of Board and Ski Officer you must:

- Be a current financial member of the Club;
- Not have been convicted on indictment or sentenced to a term of imprisonment for a summary offence required to be disclosed by the *Criminal Law (Rehabilitation of Offenders) Act 1986*;
- Not have been a bankrupt; or entered into a deed of arrangement; or made a composition which remains unpaid; in accordance with the *Bankruptcy Act 1966* or corresponding law of another external territory;
- Be eligible to hold a clearance for working with children in accordance with the *Working with Children (Risk Management and Screening) Act 2000*;
- Preferably, be a current Bronze Medallion holder;
- Must not have any negative judicial findings recorded against you in the Lifesaving movement;
- Assist in ensuring the Dicky Beach Surf Life Saving Club is working towards the mission and vision of the strategic plan and implementing the operational plan in accordance with the club's Policies and Procedures;
- Have a strong commitment to the ideals of Surf Lifesaving;
- Have a high standard of oral communication, interpersonal skills and effective volunteer management skills; and
- Have a complete understanding of the Codes of Conduct.

Objectives of the Board and Ski Officer

- Be responsible for the condition and allocation of club board's and skis in consultation with the Club Captain and Surf Sports Officer; and
- Promote the sport of board and ski racing competition throughout the Club.

Responsibilities and Duties

- At all times be subject to the direction of the Club Captain and Surf Sports Officer;
- Submit an annual budget to the Surf Sports Officer prior to 1st March each year;
- Be responsible for the care, housing and maintenance of all boards and skis and associated equipment, any expenditure shall be endorsed by either the Surf Life Saving or Surf Sports Committee;
- Submit a written report to each Surf Life Saving Operations and Surf Sports and Competition Committee Meetings;
- Develop a good working relationship with the Club Officers to manage and develop the operational effectiveness of Dicky Beach Surf Life Saving Club;
- Be active in ensuring compliance with the Child and Youth Risk Management Strategy and all Codes of Conduct; and
- Observe and encourage others to comply with the By-Laws and Policies and Procedures as prescribed in the Policies and Procedures Manual, including providing reports and other requested information on the appropriate reporting templates.

Skills and Experience

- Minimum three years general life saving involvement;
- Experience working in a volunteer organisation, preferably with surf lifesaving; and
- Preferably a proficient board or ski paddler.

Personal qualities

- Ability to work with others;
- Ability to prioritise tasks and handle multiple job workloads;
- Attention to detail; and
- Ability to adapt to a changing environment.
