By-Law 2.4 a) requires the nomination at the AGM of a panel of six members to form part of the Judiciary Committee to be called upon if and when a Judiciary Committee is needed (three persons will be called upon for every committee formed one of whom is to be a qualified barrister or solicitor – maybe retired) – By-Law 2.4 c) requires nominee to possess a thorough knowledge of surf lifesaving.

Members are reminded of By-Law 5.2 a) regarding the membership of the Life Saving Operations Committee is the Club Captain; Vice Club Captain; Chief Training Officer; IRB officer; Communications Officer; First Aid Officer; Mobiles and Vehicles Officer; Clubhouse Officer; Gear and Equipment Officer; Gym Officer. Other attendees and voting members on this committee is the Junior Activities representative; Workplace Health and Safety Officer (appointed position due to required qualifications); Youth Development Officer; and appointed Life Member (and any other officer determined by the Board).

Members are reminded of By-Law 5.3 b) regarding the membership of the Surf Sports and Competition Committee is the Surf Sports Officer; Team Manager; Surf Boat Officer; IRB Coach; Board and Ski Officer; Youth Development Officer; Coaching Co-ordinator; Club Coaches; Officials' Liaison Officer; Surf Rescue



competition representative; R&R Competition representative; Junior Activities Team Manager, a Life member nominee and any other officers as determined by the Board.

Members are reminded of By-Law 5.4 a) regarding the membership of the Building Committee is the Building and Property Officer; a nominated Director; a nominated representative of the Dicky Beach Supporters' Club; a Life Member nominee; and any other member as determined by the Board.

Members are reminded of By-Law 5.6 b) regarding the membership of the Constitution Review Committee is the Club Secretary (Chairperson); plus four members one shall have some legal background, the other members governance experience or constitutional experience.

Members are reminded of By-Law 5.13 b) regarding the membership of the Honours & Awards Committee is the Deputy President (Chairperson); Club Secretary; Chief Training Officer and two Life Members or members with a thorough knowledge of lifesaving and any other member as determined by the Board.

At the AGM there will be sheets for all committees and members who would like to assist are encouraged to indicate same by listing their names for Finance Committee; Fundraising Committee; and Club Apparel Committee

PROCESS OF ELECTION

All votes for Board positions and Vice Club Captain will be by ballot.

Proxy voting is not permitted.

Voting ballots will contain the names of the nominated person together with a yes or no or an abstain box. Members must indicate whether they support the nominee or not or wish to abstain from voting.
